Call to Order: Meeting was called to order by Sheila at 9:06am.

Approval of Agenda: Motion to approve by Renee, second by Marty. Motion passes.

**Approval of minutes from November 1, 2019:** Motion to approve by Renee, second by Kimberly. Motion passes.

# **Officer Reports**

**President, Sheila Johns:** Written report. Sheila signed the contract for Divots for 2021 NeASFAA conference in March. She'll be going to RMASFAA board meeting in Colorado on February 20-21. Has been in discussion with SFRC, but more on that later in Justin's report.

President Elect, Renee Besse: Written report.

**Past President, Marty Habrock:** No written report. Marty has been involved in the taskforce for the Treasurer-elect position.

**Treasurer, Janice Volker:** Written report. Not much activity since last meeting. The tax return for fiscal year 2019 was filed in November.

Secretary, Sarah Standley: Written report.

#### **Sector Representative Reports**

**Two-year Public Institutions, Kimberly Vanosdall:** Written report. Two responses from her sector. Sheila is going to be a grandma this summer. Erinn Brown has a new staff member named Shelby. Shelby already earned her first credential! **Private Colleges and Universities, Doug Watson:** Written report. Doug wants to have a zoom meeting with the entire sector and invite everyone.

**Four-year Public Colleges and Universities, Tabitha Haynes:** Written report. She reached out and received two responses, but nothing to report.

**Associate Membership, Shareen Thewke:** Written report. Working through philanthropy ideas for Norfolk. Discussion based around which choice to go with since we need to decide for the spring conference. We decided on Northeast Community College Food Bank since it is supporting education. Cecilia will ask around the Associate Sector to see if a company would be willing to match the money we raise. Shareen also reached out to her sector, but nothing to report.

#### **Committee Reports**

Association Governance, Marty Habrock: Written report. Marty wrote up a draft for updated P&P and sent it to his committee. One of the items was adding dropbox protocol. The second item was a committee update for the Nominations and Elections Committee (correcting the number of committee members from 5 to 4). The third update was regarding officer travel – paying travel expenses for past president to attend RMASFAA conference. The fourth update was under treasurer responsibilities – giving the treasurer the option to attend NASFAA Leadership Conference.

The final update was regarding who can make motions and vote. Once he hears back from the other members he'll get the P&P updated and get it over to Lani for her to put it on the NeASFAA website.

**Corporate Development, Cecilia Hernandez:** Written report. Cecilia emailed the associate members, and two new members will be coming to NeASFAA spring conference: Ernest Student Loans and ScolarNet. Those two will need to become members in order to vend, so Cecilia will send them a membership application.

Finance and Audit, Janet Solberg: No written report.

**Membership Connections, Lani Swanson:** Written report. We have two requests for membership, so we'll talk about those later.

**Nominations and Elections, Renee Besse:** No written report, it's going to be within the president-elect report. **Professional Development & Recognition Committee, Stacy Seim:** Written report. Fall training was very well received! Had to switch some things around because NASFAA did a webinar in the afternoon during the credential. Consumer Information and PJ credentials are coming up, and there are 8 people registered.

State & Federal Relations, Justin Brown: Written report. The committee met in January to discuss plans. They put together a briefing document for the three people who are going to the NASFAA leadership conference. Discussion about 9 bills that they are tracking right now. He also sent a poll to the membership for them to have a voice on which bills they support or not and provide commentary. They helped put together written testimony for LB920 which will effectively increase NOG. They submitted a session proposal for Ritchie to present at the spring conference. Justin also put some federal activity in his report for everyone to review. Discussion on potential updates to NOG policies and how to determine which students should receive it. Senator Vargas wants students to receive NOG no matter when they apply, discussion on how we would implement that. Discussion about potentially setting up a meeting to discuss some items with him if possible. We also had a discussion about a LB1089 that will require high school seniors to complete a FAFSA before they graduate with two opt-out exceptions. The hearing is going to be this Monday. We might want to either send someone to testify or write a letter to submit by Monday. Our stance would be neutral on this particular bill, and we would just explain the facts about FAFSA filing etc. Justin feels that we should probably be involved just to set a precedent that NeASFAA will be involved in bills that have to do with financial aid. LB1168 is also set to be heard on Monday. It would allocate lottery money for several things that we would potentially be in favor of. We also had a discussion about the SFRC committee in general and whether or not they can make decisions to be for, against, or neutral on bills. Things tend to move pretty quickly, so it would be difficult to bring all of these items to the board for a vote. It was decided that since the NeASFAA president and president-elect are both on the SFRC, that is enough representation for the committee to make a decision on behalf of the board. If individuals have a different opinion than the stance NeASFAA decides to take, individuals can testify or submit letters on their own either as representatives of their institution or representing themselves.

## **Continued Business**

**RMASFAA** in Nebraska 2020 update: Becca wrote up a report for the dropbox. Sheila will send something out to the NeASFAA listserv to ask for committee volunteers. We're also open to suggestions for philanthropy.

**Investment of checking account funds, recommendation from Finance & Audit:** We did not receive a recommendation on this, so we'll hopefully hear something by the next meeting.

Ratification of Strategic Directions document: Doug made a motion, Marty seconded. Motion approved.

**2022 Conference locations:** Cornhusker proposal is in dropbox. Graduate has provided some information, but it wasn't enough for us to be able to compare. We have requested more information from them so that we can more easily compare.

**Report from task force regarding Treasurer-Elect position proposal:** Taskforce includes Doug, Tabby, Janice, Marty, and Sheila, and they provided a written report. The proposal was to change treasurer position to one year as treasurer

elect and second year as treasurer instead of a two year term. Sheila also reached out to other states in RMASFAA to ask what they are doing. Kansas, Colorado, and Montana all have a treasurer elect. The task force felt that a three year term would be too long and that recruiting a new Treasurer-Elect each year as proposed was not a sustainable model for NeASFAA's membership. The taskforce ultimately determined to leave the Treasurer position as is with a 2 year term. However, they did feel that the Treasurer should have several meetings with the incoming treasurer to help train the new treasurer and ensure things happen appropriately. The last few treasurers have been serving 4 years in a row, so we want to try and stop that cycle. The Board of Directors and Committee Timeline will be updated with the recommendations from the task force.

### **New Business**

**Membership request from Iowa Student Loan:** Renee made a motion to approve the membership request, Doug seconded. Motion carries.

**Membership request from SoFi:** Renee made a motion to approve the membership request, Marty and Shareen seconded. Discussion about this company because they push loan consolidation, and that may be a concern for some. If we accept them, they will have access to the website, the listserv, and the ability to attend conferences, but they would not get access to our students. Motion carries.

**Budget variance for purchase of date stamp, \$60:** Finance and Audit committee recommended that the Treasurer purchase a date stamp. Renee made a motion, Kimberly seconded. Motion carries.

EducationQuest FAFSA completion initiative: EducationQuest has created an advisory council to review the prospect of requiring high school students to complete the FAFSA before they graduate. Overall, it seems like high school guidance counselors are not approving of this. This initiative is separate from LB 1089, which Senator Vargas is introducing. If the bill passes, there wouldn't be a need for the EducationQuest advisory committee to continue meeting about this unless they want to just discuss ways to help the high schools implement this. Louisiana passed something similar, and it has been a full year since it was implemented. There are a couple other states who are also implementing something similar, but they haven't started yet so there isn't any data. We may just wait until after the bill is introduced and just see what happens.

**NeASFAA Federal Briefing Document:** Justin, Carlos Garcia (SCC), Lisa Gdowski are all going to NASFAA Leadership Conference. They are going to the hill for a visit, so the SFRC came up with this document. There is a good chance of reauthorization soon. They are going to meet with 5 different staffers to discuss a few different issues.

Proposal to offer discount to 1st-time conference attendees: The PDRC talked about possibly offering a discount like this to maybe encourage some schools who usually don't send anyone to the conference. The discount would be 50% off for anyone; it wouldn't necessarily be one per school. It would probably be just for this year. If it's successful, they would talk about potentially doing it again. This wouldn't put the association in the hole much, if any. Budgets seem to be a big reason why schools don't send people, so this might be a good incentive to get a few more people, especially since RMASFAA is also in Nebraska this year. If they decide to implement this, maybe the sector reps could get the word out to their sector. Then we discussed having an early bird rate instead. This would make it so they aren't excluding anyone. It would also be nice to get numbers a little earlier. Doug motions that for the spring 2020 conference, we offer a 50% discount for all early registrations and payments through February 28<sup>th</sup> for institutional registrations. If there is any shortfall to cover the remaining cost for the conference, that can come from reserves. Renee seconded. Motion carries.

**Dropbox capacity:** It seems like the dropbox capacity is an individual thing. Certain people are getting the message that their dropbox is full, but others aren't. It seems like each individual person would need to upgrade their own dropbox. Justin proposed that we head up a taskforce to tackle this and look into options. We're thinking there won't be a free option out there, so we might need to do some research about options and pricing. Marty makes a motion to create a

taskforce to research cloud storage solutions for NeASFAA and bring recommendations to the next meeting. Doug seconded. Sheila asked for volunteers. Ritchie, Shareen, Lani, and Sarah all volunteered. Ritchie will chair the taskforce. **2020-2021 Budget Preparation:** Between now and the spring conference we'll be needing to create the budget for 20-21. Janet Solberg said she would be willing to assist with this. If not, Laura might be able to help. Renee and Marty also will likely be involved. Sheila is going to reach out to everyone to get this started.

Adjournment: Motion to adjourn by Marty, second by Shareen. Motion carries. Meeting was adjourned at 1:17pm.

### Activities:

- 1. Continue to actively engage as an ex-officio on State and Federal Relations Committee, Professional Development and Recognition Committee. I have not been involved with the Audit and Finance Committee or the Association Governance Committee to date.
- 2. I have completed the slate of candidates for the 20-21 NeASFAA Board of Directors and held elections. The results are listed below and will be ratified after the Spring Conference by the new Board.
  - a. President-Elect Justin Brown
  - b. Treasurer- Lisa Gdowski
  - c. **Private Sector Rep**-Fallon Watts
  - d. Associate Sector Rep Jodi Vandenberg
    - 87% Voting Return by Institutions
    - 20% Voting Return by Associate Sector
- 3. I have begun strategizing and taking action to outline my goals as NeASFAA President 2020
  - a. I have been doing research, with the help of Lisa Gdowski, to estimate the costs of moving NeASFAA to Quick Books online through Tech Soup (\$75/yr). Lisa also volunteered to register for a class at her college to learn quickbooks.
  - b. I have also done some research on having an external audit performed. I contacted several accountants in Columbus and was told they do not do audits. I then contacted one in Kearney and they do not perform audits either. After a discussion with the accountant he indicated it is cost prohibitive for his firm to do audits anymore, especially on 'small' associations like us. He did guestimate that it would cost between \$2000-\$4000 for an audit and they probably would not find anything wrong.
  - c. I have asked Mary Sommers to lead a task force with the goal of defining what training looks like for NeASFAA in 2020 and beyond.
  - d. I plan to have a Strategizing/Goal Setting Meeting with the new Board members following the final 19-20 Board Meeting prior to the Spring Conference in March.

# SFRC priorities for 19-20:

- 1. NeASFAA will formally thank state and federal legislators for their work on behalf of students, as needed.
- 2. NeASFAA will annually poll its membership for what state and federal issues are important to them for the upcoming year and communicate these issues to the NeASFAA Board.
- 3. NeASFAA will invite state and federal guest speakers to the NeASFAA Conference.
- Reminder: In the fall, the committee surveyed the NeASFAA membership to determine ten issues that are most important for NeASFAA to pay attention to. Those ten issues ranked in order by the membership are:
  - 1. Student Loan Repayment
  - 2. FAFSA Simplification
  - 3. Student Loan Debt Crisis
  - 4. Nebraska Opportunity Grant
  - 5. Financial Aid Verification
  - 6. Loan Counseling
  - 7. Transparency of Award Letters
  - 8. Return of Title IV Aid
  - 9. Federal Pell Grant & Year-Round Pell
  - 10. FAFSA & Need Analysis
- The committee held a meeting on January 9<sup>th</sup> to discuss winter/spring committee activities.
- The committee prepared a briefing document (copy in Dropbox) for the NeASFAA representatives
  who will attend the NASFAA Leadership and Legislative Conference, which includes Capitol Hill Visits
  with legislative staff and representatives.
  - NeASFAA members attending Hill Visits include Lisa Gdowski, Central Community College;
     Carlos Garcia, Southeast Community College; and Justin Brown, University of Nebraska
  - Hill Visits are scheduled (copy in Dropbox) for Wednesday, February 5<sup>th</sup> and the schedule will include the Nebraska Breakfast and meetings with each of the five offices for Nebraska.
- The committee has been tracking legislative activity in the 2<sup>nd</sup> session of the 106<sup>th</sup> Nebraska Legislature. There are 9 bills we are tracking (copy in Dropbox) related to financial aid. Ritchie is providing the membership with updates and the committee has been discussing each bill in detail as hearings are scheduled to determine whether NeASFAA should take an official position.
- NeASFAA took an official position on LB 920. Hearing was held January 21<sup>st</sup>. The committee drafted a letter and NeASFAA President Sheila Johns submitted our written testimony as a proponent (copy in Dropbox). The bill would reallocate the portion of the lottery funds for education. While it changes the NOG allocation from the education portion of the lottery funds from 62% to 58%, there would be an elimination to the existing 10% retainer, which means that NOG would effectively receive an increase through this bill.

- The committee sent a survey to the membership regarding their position and thoughts on each of the 9 bills related to financial aid (copy in Dropbox).
- The committee submitted a session proposal for the NeASFAA that was approved by the PDRC. Ritchie Morrow will present a session on the Legislative Process 101 followed by a panel of colleagues who have testified before a committee or have other experience with the Legislature.

# Federal and State Issues and Activity since Last Board Meeting in Chronological Order:

- On December 5<sup>th</sup>, Senate Passes Deal On Permanent HBCU Funding and Student Aid Simplification. The Senate passed a bipartisan deal, in the form of an amendment to the FUTURE Act (H.R. 2486), that would restore annual funding for HBCUs and streamline the student financial aid process. The amendment would permanently reauthorize \$255 million in annual mandatory funding for HBCUs and increase mandatory funding for the Pell Grant program by \$25 million in Fiscal Year 2020 and each succeeding year. It also includes language from the FAFSA Act (S. 3611, 115<sup>th</sup>), which would require the Internal Revenue Service (IRS) to disclose certain tax information to the Department of Education for purposes of administering federal financial aid, which would simplify the FAFSA process.
- At the FSA Conference, ED Announced Federal Student Aid Updates. Secretary DeVos proposed transforming FSA into an independent agency. Secretary DeVos said a "stand-alone government corporation, run by a professional, expert and apolitical board of governors" could better manage a more complex student loan portfolio and provide improved customer service to students. In her proposal, the independent agency would not report to the Secretary of Education. ED also confirmed that it will extend its contracts with student loan servicers for up to two more years as the Department continues to work on its "Next Gen" overhaul plan of student loan servicing.
- The New College Scorecard was published at <a href="https://collegescorecard.ed.gov/">https://collegescorecard.ed.gov/</a>
- <u>Centralized Federal Student Aid Information Hub</u>: Next Gen FSA Website Consolidation began, consolidating websites into <u>studentaid.gov</u>. Review the <u>FSA Electronic Announcement</u>, posted December 13, 2019. More information at NASFAA.
- **Distribution of Assets from Perkins Loan Fund & Cancellation Reimbursement**: Schools received notification on 12/20 of what is due to ED and what the school's share of cash and reimbursement is. Return of excess cash on hand is due February 18<sup>th</sup>.
- Congress Sent Final Appropriations Package to the President's Desk and was Signed: The House
  and Senate Appropriations Committees released two minibus spending packages for the FY20
  appropriations bills that were approved by each chamber and sent to the President. Of relevance, it
  provided for funding increases to Pell and Federal Work-Study, directed ED to publish a semi-annual
  report on each loan cancellation and discharge program, included accountability measures on
  student loan servicers, and provided \$50 mil to ED to cancel loans for borrowers who would qualify
  under PSLF.
- ED Sends Updated Foreign Gift Reporting Requirements to OMB for Approval: ED requested an emergency review by OMB for a new form for schools to complete foreign gift reporting. Foreign gift reporting is due July 31 and January 31 every year. A new electronic announcement clarifies requirements for reporting under Section 117. ED announced the new form is not ready yet, so the January 31<sup>st</sup> report must use the existing process through the E-App.

- New Foreign Gifts Reporting System Not Yet Available. The Department of Education's (ED) new foreign gifts reporting system is not yet available, and schools should use the E-App for their reporting due January 31. ED had originally planned to have the new system available for January reporting, but informed NASFAA staff that it will publish a notice in the Federal Register this week for another 30-day public comment period on the new information collection.
- Progress on Higher Education Act (HEA) Reauthorization Bills Likely in 2020. The House Education and Labor Committee is preparing to bring the College Affordability Act (CAA/H.R. 4674) to the floor in the coming weeks. The bill currently has 137 cosponsors, only 13 away from the committee's goal of 150 cosponsors by the time the bill reaches the floor. On the Senate side, Senate Health, Education, Labor, and Pensions (HELP) Committee Chairman Lamar Alexander (R-TN) and Ranking Member Patty Murray (D-WA) are continuing negotiations on a bipartisan bill. The bill could move to the Senate floor in the coming months following the Senate's impeachment trial.
- House Voted to Overturn Borrower Defense Rule. On Thursday, January 16, the House passed the bipartisan joint resolution H.J. Res. 76 to overturn the Trump Administration's borrower defense rule. The resolution passed 231-180. H.J. Res. 76 would overturn the Department of Education's new regulations governing standards for adjudicating borrower defense to repayment claims, which were finalized in September 2019 and are set to take effect on July 1, 2020. The new regulations create narrower criteria for borrowers to claim they were defrauded by their college or university, a change which the Department estimates will save taxpayers more than \$11 billion over the next decade. The White House threatened to veto the resolution in a statement.
- Treasury Department Releases Guidance to Expand Tax Exemption for Student Borrowers. On January 15, the Treasury Department and Internal Revenue Service (IRS) issued guidance that will expand tax relief to borrowers who have been defrauded by institutions of higher education or the closing of an institution. The guidance exempts borrowers from paying federal taxes on students loan discharges received from a "closed school" or a borrower defense to repayment (BDR) claim. The tax relief also applies to private student loans that have been discharged as a result of legal settlement involving "unlawful business practices." The guidance states that borrowers are not required to increase their gross income as a result of the loan discharge on a federal income tax return.
- Office of Federal Student Aid Personnel Changes. Chief Operating Officer of the Office of Federal Student Aid (FSA) Mark Brown announced several personnel changes. FSA has been working since April 2019 in an ongoing effort to reorganize the roughly 1,000-person office and hire more staff for its Next Gen student loan system overhaul. Changes include:
  - o Pam Eliadis will become the new Deputy Director of the Next Gen Program Office.
  - John Festa will serve as a Senior Advisor for the Next Gen Program Office.
  - David Albers, previous Chief Performance Office of FSA's Enterprise Performance
     Management unit, will be the Deputy Chief Operating Officer for Strategy, Innovation, and Transformation.
  - Quay Crowner, previous Chief Administration Officer, will be the Director of Executive Services.
  - o Miryam Brunson will serve as the new Chief Administration Officer.
  - Sid Evans, Director of Human Resources, will leave the role to lead FSA's "Manpower Study" of its current staffing and contracting needs.
  - o Joe Mastrianna will be the Acting Director of Human Resources.

Dear Education Committee,

On behalf of our broad membership of more than 50 institutional and associate members of the Nebraska Association of Student Financial Aid Administrators (NeASFAA) we would like to thank you and the Education Committee for continued support of postsecondary education in the state. As an organization of professional financial aid administrators committed to assisting students in obtaining a postsecondary degree, one of NeASFAA's core objectives is to support programs that positively impact the affordability and accessibility for students enrolled in postsecondary education. Therefore, we wish to present testimony in support of LB920.

The Nebraska Opportunity Grant (NOG) is Nebraska's only need-based financial aid program that financially assists college students from low-income families. In 2018-19, the program was able to assist one-third of the eligible students at an average grant of \$1,409.73. With the discontinuance of the 10% lottery fund reserve, we understand this would effectively increase the percentage of lottery funds allocated to NOG from 56% to 58% and, therefore, we support this bill. The NOG program is an important part of the overall financial aid strategy of eligible Nebraska students, and this increase would allow for an expansion of recipients and/or increased award amounts.

The Access College Early (ACE) Scholarship is a program to help eligible low-income high school students take college coursework, either through dual-enrollment or early admit programs. Studies have shown that high school students who take college coursework while in high school enroll in college at higher rates, are more likely to persist, and graduate from college at a higher rate than their peers who do not complete early college coursework. In 2018-19, 2,309 low-income high school students from 223 public and private high schools were awarded an ACE Scholarship. These students took 4,057 courses, and 76% of the grades received was a B or higher. Receiving additional funding from the lottery program for the ACE Scholarship will allow additional students the ability to take advantage of this very successful program.

These figures illustrate how valuable need-based aid for postsecondary education is to Nebraska students, and NeASFAA would again like to thank you for your commitment to this funding. 



It reduces the amount of classes that students take at Universities and will help to ensure that students will graduate in 4 years.


Many institutions offer dual enrollment opportunities for Nebraska high school students. The community colleges should not receive specific support to do so if other institutions are not supported by the state.







I am only in support of this bill if there are robust opt out provisions for family's that do not want to participate.


High school students and their families should not be required to fill out this application. Many students do not go on to school. There is significant confidential information on the form. High schools are not properly trained to assist with this.

EducationQuest FAFSA Completion Initiative Report from Vicki Kucera January 13, 2020 meeting

Basically we met for a little under two hours. Liz Koop gave a presentation on some data EducationQuest had put together. She talked abou the three other states that had already made FAFSA filing mandatory for high school seniors (Illinois, Louisiana, and Texas). Louisiana was the first state and they started in 2014-15. They went from a completion rate of 48% to 82.6%. The other two states started too recently to really have any data.

Unfortunately there was really no data from Illinois regarding how it affected college enrollment.

The first meeting pretty much just provided a forum for all present to discuss the ramifications. There was certainly a concern among high school counselors about the lion's share of the work and data collection falling with them, although all present at the meeting were in favor of it. There was also some discussion about the opt out process. There was also concern about whether or not schools wanted to really sink their teeth into the notion of not graduating students who didn't file or opt out.

It was very good discussion and a great starting point; however, no concrete decisions were made at that this meeting other than to continue exploration.

Next meeting date not set.

### **Rule 10 Discussion**

 Nebraska high school accreditation, known as <u>Rule 10</u>, is open for revisions; timeline to submit proposed changes will end late summer/early fall

A significant consideration is requiring the FAFSA as a high school graduation requirement as it will remove a barrier and increase access for more Nebraska students who want to pursue education beyond high school.

 Must examine if requiring the FAFSA would be a problem for some students and burdensome for school counselors. We don't want the requirement to be taxing on the school staff.

### Discussion on challenges if FAFSA was a high school graduation requirement:

- Required parent/guardian involvement
  - FAFSA completion as a graduation requirement is flawed because it is a student requirement but must include parent's action; schools don't have control of parents.
  - For at-risk students, we don't want to create an additional barrier; parent involvement is sometimes already a challenge during the high school graduation process.
  - Sometimes students graduate high school in spite of their parents (the parents don't want the student to be successful or go to college).
  - Parents need to be educated as to why they need to complete the FAFSA what
    is in it for them? All class levels (high, middle, low income) would need to
    understand the "why."

- Families need to understand how affordable college is in Nebraska and what opportunities postsecondary education can provide.
- Counselor involvement with FAFSA filing
  - o Not enough counselors in Nebraska student/counselor ratio is already high
  - Concerns about ethics and liability
    - What have other states done? (graduation and NCAA eligibility are important examples of past mandates that have fallen on counselors)
    - What could happen if a school provided bad/wrong information? FAFSA process is invasive, provides access to personal financial information, and is outside the scope of educator training.
    - Concerns were raised over privacy.
  - Counselors don't have access to free or reduced lunch information.
- Are there other partnership opportunities (besides education) that could have a better impact?
  - Department of Health and Human Services or other state agencies; Donna Hoffman has worked with Nutrition Services to include FAFSA completion language in letters sent statewide
  - Tie FAFSA completion to getting financial benefits; if students want access to benefits, they MUST complete the FAFSA; train case managers to help complete FAFSA
  - o It needs to be connected to FRL rates; can we use info we already have as a way to separate from the education component?
  - o What role could higher education play in helping students complete the FAFSA?
  - o Could the action be incentivized? What would that look like?
  - Is there another way of accomplishing this that would make students want to complete the FAFSA – such as the Tennessee Promise program?
- FAFSA as part of curriculum such as financial literacy
  - If part of the curriculum students would be taught how to file the form and understand that it has to be done every year so they could be self-sufficient in the future. A "one-and-done" approach will not teach this.
  - Curriculum is under local school control
  - Social Studies Standards- these standards were recently approved by State Ed Board; could it be included in Nebraska Career connections; how to ensure it gets done?
  - Helps ensure buy-in from the entire school and not just the responsibility of the counselors. More than counselors will have to be understand how the FAFSA works, why it is important and be trained on completing the form.
- Other related items
  - What is the deadline? How to layer in the steps into the education system? How to create urgency so it actually gets done?
  - o Ideally, FAFSA completion would be tied to filing taxes
  - MOEC has worked hard to get more FAFSAs filed; tried many different tactics such as candy, notes home, events, etc. and the numbers have not increased dramatically. There could be merit to putting "meat" into the action; it will make the kids to complete the form.
  - A FAFSA requirement brings the form to heightened awareness: this will potentially break the poverty cycle.

### Opt out discussion

- It would be helpful to know why students are opting out; the reasons may identify barriers people are facing.
- Do students get to choose reason for opt out?
- Could there be an Opt Out with no reason given?
- What about students who have plans other than college and don't want to complete it?
- DACA and undocumented students are a concern; tracking by schools could be an issue: student may not want to be identified in anyway.

## CONCEPTS SUPPORTED IN HEA REAUTHORIZATION

### Federal Direct Loans

- Eliminating Origination Fees (Sec. 4302 of CAA). Loan origination fees are an
  unnecessary complexity and burden that is confusing for students and were
  created to offset risk for bank-based lenders. Eliminating these fees would
  provide students access to funding that would be directly applied to their
  education needs rather than a percentage returned to the federal government.
- Eliminating Subsidized Usage Limits (Sec. 4302 of CAA). These limits are burdensome and confusing for students. Existing federal loan maximums (annual and aggregate) and Pell limits already establish maximums without this policy.
- Eliminating Capitalized Interest During Forbearance or Deferment (Secs. 4102, 4103, and 4106). This provision would lower the cost of borrowing for students.
- Reinstatement of Subsidized Graduate/Professional Student Loans (Sec. 4302).
   Reinstating the loan subsidy will support needy graduate students.
- Simplify Repayment Options. Repayment plans are complex and confusing. A single income-driven plan with a fixed repayment schedule, payments capped at a certain percent of income, and debt forgiveness after a certain number of years of payments would benefit borrowers and help them fulfill their debt obligation.

### Access and Affordability

- Strengthening the Pell Grant Program (Sec. 4011-4016 of CAA). Increasing maximum Pell by \$625, expanding lifetime limits to 14 semesters, and indexing the award to inflation would expand access to the needlest students.
- **Simplifying the FAFSA and financial aid verification.** The new FUTURE Act signed into law late in 2019 will accomplish this by direct data-sharing between the U.S. Department of Education and the IRS. This is a huge win for students, thank youl

## AREAS TO BE ADDRESSED IN HEA REAUTHORIZATION

### Federal Direct Loans

- Annual Loan Counseling (Secs. 4608 and 4612). The Department of Education is best positioned to conduct loan counseling rather than require schools to provide for annual loan counseling. Additionally, mandated annual counseling could be an additional barrier for students. Provide the option for annual loan counseling, perhaps as an experimental site, and analyze the results.
- Eliminating Loan Proration. Student loan borrowing is controlled by annual and aggregate loan limits. Schools are currently required to reduce loan eligibility by prorating the final semester when no other loan proration exists in a student's college career. This serves as a barrier to completion for students.
- **Simplifying Return of Title IV Aid.** Known as R2T4, this process is most confusing and damaging to the very students financial aid is designed to help. It is time to revisit the law and find a better way to attend to the needs of students who completely withdraw, in a way that is fair to all financial aid recipients.
- Increasing Undergraduate Loan Limits with Option for Institutional Limits.
   There have been no adjustments to undergraduate loan limits for over 10 years.
   Students are increasingly relying on parent or private loans to fill the gap.
